NYACT in conjunction with the National Insurance Crime Bureau, the New York City Police Department, the New York State Department of Motor Vehicles and the New York State Police will co-sponsor a 4-Day Advanced Auto Theft School, set for Monday, March 1<sup>st</sup>, 1:00 pm\* through Thursday, March 4<sup>th</sup>, 4:00 pm (\*REGISTRATION is set for MONDAY, 12:00 PM to 1:00 PM). This course is being offered to law enforcement personnel only and will be free of charge. Lunch will be provided complimentary as well for all attendees. Detective Thomas Burke of the NYPD Auto Crime Division will teach the multi-day Advanced Auto Theft School course. The course will cover basic VIN information, altered titles and registrations, chop shops, insurance fraud and other topics related to auto theft and insurance fraud. **From East or West:** Take the Thruway to the Route 81 exit. Then take Rt 81 north to the Airport exit. (Eileen Collins Blvd) \*

**From North or South:** Take Route 81 to the Airport exit. (Eileen Collins Blvd) \*

\* Follow Eileen Collins Blvd and then follow the signs to the parking garage or surface lot. There is a charge to park in either the garage or the surface lot.

**DIRECTIONS to TRAINING ROOM located in the Main Terminal:**

Once inside the airport the conference room is up the ramp, within the main terminal, to the rear of the airport interactive area (there will be a number of activities for passengers including a cockpit of a jet). The room is not identified. Attendees will not need to pass through any security check points.
